Energy Policy – Byggfakta Group

Goal and Vision

Byggfakta Group attaches great importance to the responsibility to minimize, whenever it is possible, the environmental impact of our operations. We are aware that a healthy environment is crucial to achieve a sustainable society, and of the danger of not addressing today's environmental challenges. As a business we aim to be a NetZero organisation by 2030.

Byggfakta Group's operations, particularly involving the operation and maintenance of our offices and other buildings use energy. Our most material direct energy demand is through the procurement of electricity and natural gas to run, heat and cool our premises.

Though we are predominantly a technology focussed business and by default our environmental impact is low when compared to businesses in other sectors, we do note that energy use is an area where the impact we do make, can be minimised. Our goal is to reduce the impact our group makes through energy consumption and in so doing, reduce our carbon emissions.

Description

The aim of this policy is to set out clear measures which each of our business units must adhere to and/or aim towards in respect of electricity and natural gas demand.

As of 2022 Byggfakta Group operates in 22 regions internationally. All of the business units within these regions rely on electricity to operate their buildings. A number of the business units in certain regions, particularly those within cooler climates, also rely on the use of natural gas to heat their buildings and generate hot water for use by staff.

Our policy is to continually reduce the emissions associated to our energy consumption and minimise our environmental impact.

Delivery and Monitoring

Our goal and vision will only be realised through robust implementation of these actions. The below points, set out what Byggfakta Group promises in respect to our commitment to climate change mitigation and the decarbonisation of our business.

Byggfakta Group will:

- Ensure that all premises operated by our business units use where possible, only 100% renewable sourced electricity tariffs
- Reducing our consumption of natural gas and where it is not possible for reduction, to utilise
 alternatives and/or ensure that natural gas procured is climate compensated via the tariff or
 by Byggfakta Group.
- Evaluate our offices and produce a plan to reduce the energy consumed within each building
- Work with our staff and suppliers to reduce energy consumption
- Report annually and define the quantity of renewable and non-renewable energy used by individual business units
- Consider implementing projects that enable the decarbonisation of Byggfakta Group
- Engage with our employees to minimise energy consumption in both their working and personal lives.

Additional Considerations

As a technology focussed business, Byggfakta Group places large reliance on the use of data centres to surface our platforms to the industry and to hold information in respect to our clients, their businesses and their products/services. Byggfakta Group is aware of the energy demand of data centres is significant and will engage with our suppliers to understand their energy efficiency strategy and to ensure that a clear decarbonisation goal is set. We will work towards reporting the Scope 3 carbon emissions from these sources. We will include energy efficiency as one of the selection criteria when choosing a host platform for or services.

This policy will be reviewed at minimum annually and revised where appropriate.
